There was a regular meeting of the Board of Commissioners of G. B. Cooley Hospital Service District held on <u>Thursday</u>, <u>August 10</u>, <u>2023</u>, at 4:30 PM in the Board Room of the G. B. Cooley Administration Building located at 211 N. 3rd Street, Monroe, LA.

<u>Call to Order:</u> Dan Sartor, Chairperson, called the meeting to order, there being a quorum present.

Public Comments: There were none.

<u>Minutes:</u> The minutes for July 13, 2023, Board meeting were presented. The minutes were previously forwarded to Commissioners. A motion was offered by Cindy Johns, seconded by Taronda Goodin, and unanimously carried by the Commissioners present to waive the reading of the minutes. Reports:

Jimmy Sanderlin, CFO presented the Financial Report. Report was for the month of June and the twelve months ending June 30, 2023. Operating Revenues were over budget for the month by \$185,113 and over budget for the year by \$455,169. Operating expenses for the month were under budget at \$54,107. Year to date was under budget by \$190,215. For the month the revenue exceeded expenses by \$261,801 and year to date revenue exceeded expenses by \$964,388. For expense comparison variances of 5% and \$5,000 were used as the model. No expenses were over budget. Supplies, Clothing, and Recreation were over the threshold.

Ben Pitts, Hospital Director, presented the June report. The facility total census was (142) with (113) in community homes; (29) in SIL; (0) in TGH. There were (0) discharges in June and (0) were admitted in community homes. An update was given on the Human Resources Department applications and separations.

<u>Public Comments:</u> There were none.
